The ideal applicant will have experience and expertise in the ability to evaluate, diagnose, and navigate appropriate treatment modalities for clients in need of mental health and/or substance use treatment. The person offered this position will have space and opportunity to work toward a full time caseload if desired and will be most successful if they are open to some evening and weekend availability.

Responsibilities:

- Supports evaluation and clinical feedback regarding supervisee caseload to enhance patient outcomes and act as a positive change agent for quality patient care.
- Conducts assessment of patient's psychosocial spiritual status and functioning in an effort to document history and identify preliminary items for appropriate diagnosing and treatment planning.
- Facilitates and develops a comprehensive, individualized plan of treatment for serving clients.
- Formulates a treatment plan using client and solution focused techniques, with applying knowledge related to substance abuse risk factors and counseling modalities.

- Provides and/or arranges for therapeutic interventions as appropriate for patients in a crisis situation.
- Have a wide range of knowledge related to appropriate referral sources to coordinate quality level of care in meeting client needs in serving areas.
- Prepares and maintains reports and case histories via supervision documentation.
- Participates in the review of clinical issues and program policies and procedures.
- Team oriented and collaborative approach related to evaluating professional performance and in coordinating quality level of care for serving clients.
- Attends staff meetings and team conferences' leads team meetings as required.
- Performs miscellaneous job-related duties as assigned.

- Active Certified Licensure valid in the state of Ohio- NP, LSW, LISW, LISW-S, LPC, LPCC, LPCC-S.
- Positive attitude and open approach to patients, staff, and working relationships in the community.
- Ability to effectively communicate verbally and through written communication.
- Strong knowledge of mental health disorders and/or addiction treatment and recovery.

- Must have at least 2 years experience in the clinical field with diagnosing and/or supervising.
